

### **Mateusz Szczurek**

A graduate of the University of Warsaw and the University of Sussex, Faculty of Economics. He also obtained a Ph.D. from the University of Sussex. He completed his bachelor's degree in Economics at Columbia University. He has lectured at the University of Sussex, the University of Warsaw, and the Warsaw School of Economics. He is a member of the research team at the CASE Institute and an expert in the Polish Employers' Organization.

Mateusz Szczurek has been a member of the European Fiscal Board since 2016. In the same year, he also assumed the position of Chief Economist at the European Bank for Reconstruction and Development. From 2013 to 2015, he served as the Minister of Finance of Poland. From 2011 to 2013, he was the Chief Economist for Central and Eastern Europe at ING Bank and was Poland's representative on the Business and Industry Advisory Committee to the OECD. From 1997 to 2011, he was employed at ING Bank Śląski S.A., including as Chief Economist.

He has also been the author of numerous publications and public appearances on economic, financial, and fiscal topics.

### **Jarosław Dąbrowski**

Jarosław Dariusz Dąbrowski is a graduate of law studies at the University of Warsaw. He holds an MBA diploma obtained at the University of Brussels and the University of Warsaw. He is also an AMP postgraduate diploma from the University of Navarra/IESE Business School. He also studied at Edinburgh University Management School as part of the Know-How Fund scholarship created by Margaret Thatcher.

Since 2019, he has been the President of the Management Board of DF Capital & Management sp. z o.o., a company involved in the implementation of projects in the area of investment banking, M&A transaction advisory and strategic consulting for the banking, insurance and investment fund sectors. From 2017 to 2018, he worked at SGB Bank S.A., where he first held the position of advisor to the Management Board and then First Vice-President of the Management Board responsible for managing the bank, supervising the bank's restructuring process, as well as the development strategy.

From 2015 to 2017, he was the Chairman of the Supervisory Board of Michael/Ström Dom Maklerski sp. z o.o. (formerly DF Capital Dom Maklerski sp. z o.o.). From 2010 to 2014, he was the President of the Management Board of DF Capital Dom Maklerski sp. z o.o., which he founded.

From 2004 to 2009, he was the President of the Management Board of Bank DnB NORD Polska S.A. (formerly Bank NORD L/B Polska S.A.) and BISE S.A., which was later merged with Bank DnB NORD Polska S.A. From 1997 to 2003, he was a Member of the Management Board and then Vice-President of the Management Board of Raiffeisen Bank Polska S.A., where he was responsible, among others, for corporate banking, SMEs, as well as leasing and factoring.

From 1995 to 1997 he was the President of the Management Board of the National Investment Fund PROGRESS S.A. From 1994 to 1997 he was employed at the Raiffeisen Atkins Fund Management Consortium S.A., where he held various positions, including President of the Management Board and General Director.

From 1992 to 1993, he worked in managerial positions at the Office of the Council of Ministers.

In 2019, he was a member of the Supervisory Board of ABC Data S.A., listed on the Warsaw Stock Exchange. From 2013 to 2015, he was a member of the Supervisory Board of MCI Capital S.A.,

also listed on the Warsaw Stock Exchange, and earlier, from 2010 to 2013, he was a member of the Supervisory Board of PBP S.A. (currently Nest Bank).

Jarosław Dąbrowski is also passionate about the Polish and world's twentieth century economic and political history as well as present geopolitics. His current interests also include areas related to ESG, in particular the digital, climate and social transformation of Poland and the rest of the world.
