This report has been prepared in accordance with the provisions of Article 100e of the POSA and pursuant to Article 2 of the Agreement for the performance of the function of "Bondholders' Trustee" entered into between Financial House Ever AD and Eurohold Bulgaria AD (the "Issuer", the "Company").

1. Information about the bond issue:

✓ Eurohold Bulgaria AD is a public company within the meaning of the Securities Act. The company's shares are traded on the markets of the Bulgarian Stock Exchange with stock code: EUBG and the Warsaw Stock Exchange with stock code: EHG.

There was no change in the majority shareholder of the Company during the reporting period.

- 2.4. Amendments and/or additions to the Articles of the Company.
- ✓ On November 25, 2024, at an extraordinary General Meeting, a decision was made to amend the Articles of Association of the company, mainly concerning the issuance of warrants by the company. The current Articles of Association were entered in the Register of Shareholders on December 3, 2024.
- 2.5. Transformation of the Company.
- ✓ No resolution has been passed to convert the Company
- 2.6. Share capital increase of the Issuer and/or its subsidiary
 - \Rightarrow During the reporting period, no capital increase of Eurohold Bulgaria was carried out and no decision for such increase was taken.
 - ⇒ On 18 March 2024, Eurohold Bulgaria AD made an additional capital contribution to the subsidiary Eastern European Electric Company II B.V of EUR 940,000. The amount was paid to EEEC II B.V. in two tranches EUR 600,000 on 14 March 2024 and EUR 340,000 on 15 March 2024.

⇒ On 29 March 2024, IC Euroins AD (Euroins Bulgaria), part of Eurohold's insurance group - Euroins Insurance Group AD (EIG), applied to register its capital increase of BGN 20 million with the TR.

The capital increase is through the issue of 5,000,000 new shares with an issue value of BGN 4 each, of the same type and class as the company's existing share issue, with a nominal value of BGN 1. The amount of the capital increased from BGN 410 971 200 to BGN 44 721 200, with the shareholding of Euroins Insurance Group AD in the capital of IC Euroins being 98.88%.

⇒ On 30 May 2024, at an extraordinary general meeting of shareholders of Eurohold Bulgaria AD, a resolution was passed for the company to issue warrants in the amount of up to 260,500,000 (two hundred and sixty million and five hundred thousand) units of dematerialised, registered, freely transferable warrants under the terms of a public offering pursuant to the Public Offering of Securities Act, with an issue value of BGN 0.50 (fifty cents) each, which entitle the warrant holders to exercise within 10 years their right to subscribe for the respective number of shares (of the same type and class as the existing issue of shares of the Company - dematerial, registered, non-preferred, with the right to 1 (one) vote in the General Meeting of Shareholders of the Company, with the right to dividend and the right to liquidation share) - the underlying asset of the warrants at the issue value of BGN 2.00 (two levs) per share at a warrant/share conversion ratio of 1: 1, which Eurohold Bulgaria plc will issue in future capital increase(s), provided that the new shares are subscribed by the warrant holders. The public offering of the warrant issue will be deemed to have been successfully completed only if at least 78,150,000 units of the offered warrants, representing 30% (thirty percent) of the offered securities, have been subscribed for and fully paid.

On December 10, 2024, the subscription for the issue of warrants issued by Eurohold Bulgaria AD ended.

The results of the public offering are as follows:

- 1. Start of the subscription: 25.11.2024
- 2. Date of completion of the subscription: 10.12.2024
- 2. Total number of subscribed and paid warrants: 260,481,631 warrants.
- 3. Amount received from the subscribed warrants: 130,240,815.50 BGN.
- ⇒ On December 20, 2024, at a meeting of the Board of Directors of Euroins Insurance Company, a decision was made to increase the company's capital in accordance with Art. 195 in connection with Art. 196, para. 3 of the Commercial Act from BGN 49,721,200 to BGN 62,221,200, through the issuance of a new 12,500,000 shares, with a nominal value of BGN 1 (one) and an issue value of BGN 4 (four) each, of the same type and class as the existing issue of shares of the company ordinary, registered, dematerialized, non-preferred shares with voting rights. The new shares from the capital increase were fully subscribed and paid for by the majority shareholder Euroins Insurance Group AD and entered in the Commercial Register on December 20, 2024.
- \Rightarrow On January 16, 2025, an entry was made in the Commercial Register of the simultaneous increase and decrease in the capital of Euroins Insurance Group AD.
- ⇒ The decision to simultaneously decrease and increase the capital of Euroins Insurance Group AD (EIG AD), pursuant to Art. 203 in connection with Art. 252, para. 1, item 5 of the Commercial Act, was taken on November 11, 2024 by the General Meeting of Shareholders. According to the decision:
 - The capital of EIG AD was reduced from BGN 576,242,734 to BGN 119,932,734 through the cancellation of 442,212,912 ordinary, registered, available shares and 76,981,791 preferred, registered, available shares with a par value of BGN 1 each.
 - At the same time, the capital was increased from BGN 119,932,734 to BGN 149,932,734 through the issuance of 30,000,000 shares, of which Eurohold Bulgaria AD subscribed and paid in December all 30,000,000 shares at an issue price of BGN 5.83 each or a total value of BGN 174,900 thousand.

The capital of Euroins Insurance Group AD as of the date of this report amounts to BGN 149,932,734, distributed into 149,932,734 ordinary, registered, outstanding shares with a par value of BGN 1 each, with the change being entered in the Commercial Register on 16.01.2025. The percentage of participation of Eurohold Bulgaria AD increases from 90.01% to 92.08%.

2.7. Structural changes in the Issuer's economic group, including: establishment, acquisition or sale of subsidiaries.

For the reporting period 1 January – 31 December 2024, the following changes have occurred in the group of companies of Eurohold Bulgaria AD:

✓ On September 12, 2024, the transfer of ownership of all shares held by EIG in ICLAIM Sole Proprietorship for Claims Settlement Services P.K., Greece to a new owner was entered in the Commercial Register of Greece after a purchase and sale agreement of the company was concluded. As of the date of entry, ICLAIM is not part of the EIG group.

2.8. Acquired shares of other companies with minority interests.

3. Expenditure of the bond loan funds

The purpose of the bond loan is to raise funds to be used for the following purposes:

- reducing the indebtedness of the issuer, by repaying short-term and/or long-term liabilities of the company in an approximate amount of up to EUR 20,000,000 (twenty million euros);
- support of the operational activity of existing subsidiaries of the issuer, and this support can be implemented through:
- part of the funds raised, the Issuer can use to finance the initial costs of the transaction with CEZ, in case of positive approval by all regulatory authorities;
- provision of working capital for the needs of the issuer.

The funds raised were spent as follows:

The funds raised from the issued bond loan in the amount of EUR 30,000,000 or net proceeds EUR 29,974,717 after deducting the costs of the private offering, were used to fulfill the objectives set in the Proposal for the subscription of the present issue of corporate bonds, as follows:

- ✓ According to item 1 of the objectives of the bond loan repayment of short-term liabilities of the Company to non-banking institutions - Euro Commercial Book (ESP) (during the period of 2020, three issues of Euro Commercial Book were issued, repurchased and early repaid and deleted from the registers (ESP), with a total nominal value of 20,200,000 Euros;
- ✓ According to item 2 of the objectives of the bond loan additional payment of subscribed but not paid-in capital of the subsidiary "Euroins Insurance Group" AD in the amount of 9,588,532 Euros.
- ✓ "Eurohold Bulgaria" AD did not provide an interest-bearing loan to a subsidiary of the issuer or to its subsidiary;
- ✓ According to item 3 and item 4 of the objectives of the bond loan, namely in connection with initial costs and necessary working capital related to the transaction for the acquisition of CEZ Assets, all remaining funds from the raised bond issue amounting to 186 185 Euro.

4. Financial indicators

Financial indicators are calculated at the end of each quarterly period based on consolidated financial statements. The issuer undertakes to maintain a ratio:

"Liabilities/Assets" ratio - maximum value of the indicator for the term of the bond loan - 0.98.

Value of the indicator as of 31.12.2024 r.: 0.90

The "Liabilities/Assets" ratio is calculated based on data extracted from the latest published unaudited interim consolidated financial statements of Eurohold Bulgaria AD at the following values: "Liabilities" - in the amount of BGN 2 488 335 thousand and "Assets" - in the amount of BGN 2 766 304 thousand.

Coefficient "Coverage of interest costs", calculated according to the provision of Art. 100b, para. 2 of the LPA, as the consolidated profit from the usual activity increased by the interest expenses, divided by the interest expenses - minimum value of the indicator for the term of the bond loan - 1.01.

Value of the indicator as of 31.12.2024: 1.32

The "Interest Expense Coverage" ratio is calculated based on data extracted from the latest published unaudited interim consolidated financial statements of Eurohold Bulgaria AD at the following values: "Consolidated profit from ordinary activities" - in the amount of BGN 38 943 thousand and "Interest Expenses" - in the amount of BGN 120 820 thousand.

As of the date of the last published unaudited interim consolidated financial report – 31.12.2024, Eurohold Bulgaria AD fulfills the commitments made to comply with the specified indicators until the maturity of the issued bond loan with ISIN code: BG2100013205.

5. State of the security under the bond issue

The current bond issue is secured by the "Bond Loan" Insurance Contract - Insurance Policy No. 1290010000061/30.12.2020, Addendum No. 1 to it from 01.06.2021. and Addendum No. 2 dated 02.07.2021, which was concluded between the issuer "Eurohold Bulgaria" AD, as insurer and "Euroins Insurance Company" AD, EIK 121265113, as insurer, for the benefit of all bondholders (represented by the elected trustee of the bondholders - "FINANCIAL HOUSE EVER" AD), which have the status of insured, with coverage of 100% of the risk of non-payment by "Eurohold Bulgaria" AD of any and all interest and/or principal payment (regardless of the basis for liability and demandability, including in cases of declaring the issue as early demandable), with the effect of the insurance contract until the date of full repayment of the bond loan. The insurance contract does not cover interest for arrears, penalties and any other obligations of the Issuer, except for its obligations to pay principal and interest on the Issuer's bonds.
