Votum

4Q24 financial results expectations

On April 8 Votum will release 4Q24 financial results. We assume it was a good quarter for the Company mainly due to the record high results of the segment for pursuing claims from the abusive clauses in the loan agreements. Seasonally 4Q is the best period for this segment and thus it will be the most important area for revenues and margins. As far as the remaining business segments are concerned, we expect a flat yoy result in the rehabilitation segment (fewer number of NFZ contracts) and a strong negative voy dynamic in the segment of pursuing claims for indemnity (the Company's withdrawal from pursuing claims from property damage translates into a contraction of volume of cessations). Ultimately, we expect strong revenues and a comparable yoy profitability in 4Q24, therefore we forecast NI at PLN 48.2 million (up 21% yoy).

The banking segment driving a revenues growth.

The Group should report record high revenues in the segment of pursuing claims from the abusive clauses in the loan agreements which features a higher number of the 1st instance courts decisions allowing the Company to recognize revenues from the success fee coupled with an increasing number of agreements signed with specific banks - this particularly should be more and more visible as a number of the banks willing to finally close the chapter of the legacy CHF loans increases and a volume of the agreements signed is on the rise which the statistics show. Besides, a pace of new clients acquisitions in this segment should be decent vs the previous quarter, we believe. The remaining segments should report either slightly lower sales than a year before (the rehabilitation segment) or materially negative dynamic (the segment of pursuing claims for indemnity withdraws from pursuing claims from property damage). We forecast total 4Q24 revenues at PLN 139.1 million.

Seasonally higher margins. We assume a strong seasonal qoq increase of the EBITDA and EBIT margins mainly due to extra success fee revenues. We do not expect any visible effect from a staff reduction at the moment; it should surface in the future. We forecast 4Q24 EBIT margin at 41.8% (high, albeit flat yoy) which should translate into a PLN 58.1 million EBIT. We expect a positive net financial result due to stronger impact of a discount reversal. According to our estimates, the Group's net profit should arrive at PLN 48.2 million (up 21% yoy).

Financial forecasts

We adjust our FY24 expectations to our more detailed 4Q24 forecast.

Recommended action

We uphold our recommendations: LT fundamental Hold and ST relative Neutral.

DM BOŚ S.A. generally values the covered non bank companies via two methods: comparative method and DCF method (discounted cash flows). The advantage of the former is the fact that it incorporates the current market assessment of the value of the company's peers. The weakness of the comparative method is the risk that the valuation benchmark may be mispriced. The advantage of the DCF method is its independence from the current market valuation of the comparable companies. The weakness of this method is its high sensitivity to undertaken assumptions, especially those related to the residual value calculation. Please note that we also resort to other valuation techniques (e.g. NAV-, DDM- or SOTP-based), should it prove appropriate in a given case.

KEY TO INVESTMENT RANKINGS

Buy - fundamentally undervalued (upside to 12M EFV in excess of the cost of equity) + catalysts which should close the valuation gap identified;

related to the residual value calculation. Assumptions used in valuation can change, influencing thereby the level of the valuation. Among the most important assumptions are: GDP growth, forecasted level of inflation, changes in interest rates and currency prices, employment level and change in wages, demand on the analysed company products, raw material prices, competition, standing of the main customers and suppliers, legislation changes, etc. Changes in the environment of the analysed company are monitored by analysts involved in the preparation of the recommendation, estimated, incorporated in valuation and published in the recommendation whenever needed.
